Item pulled for discussion prior to action**Resolution 2010-3 Promoting Clean And Energy Efficient Motor Vehicles, Energy Independence, Zero Emission Technologies And Improved Quality Of Life In California**

In response to questions regarding the request to adopt this resolution for which a revised copy was distributed, Jacki Bacharach explained that the original resolution was changed and comments added about South Bay projects, and now the Lung Association representatives have requested to add more about zero emissions and technology. Jacki recommended the COG support the revised resolution.

In response to Board Member Goodhart's inquiry regarding whether the Lung Association's was asked to make specific changes to align with our request, Jacki Bacharach responded that she was supposed to add clauses specific to the South Bay and the Association commented on the changes after the agenda was published, but she has reviewed the comments and concurs with the changes which are minor.

MOTION by Board Member Blackwood, seconded by Board Member Goodhart, to approve Resolution No. 2010-3, as revised. No objection. So ordered.

PRESENTATIONS**Green Idea City: Hermosa Beach's Carbon Neutral Effort -- Presentation** by Hermosa Beach Mayor Michael DiVirgilio

Mayor DiVirgilio addressed the Board regarding Hermosa Beach's "Green Idea City" and their efforts to become Carbon Neutral. He explained that in order to do so, a city must account for its entire carbon footprint by offsetting all its activities that produce carbon dioxide with efforts that either remove the greenhouse gas from the atmosphere or produce no pollution at all. He said the main question to ask is: To what degree of rigor do we want to be to accountable for our carbon?

Mayor DiVirgilio explained that Hermosa Beach is a small almost all residential community of 1.3 square miles with a small tax base and almost no industry driving the tax base. He said this forces them to be innovative and this is historically true about Hermosa. Some examples include: the Lighthouse Café; "Pennywise" punk music; Greg Noll, the big-wave surfer; Warren Miller, filmmaker; volleyball; Comedy and Magic Club; 1736 House protects people from domestic violence—all started in this small town of 1.3 square miles.

Mayor DiVirgilio said Hermosa Beach is already signed on to Cool Cities—noting they have a Green Task Force with progressive policies—green building; waste; water and energy conservation; storm water infiltration; small wind energy; bike master plan; alternative fuel vehicles.

The Spark: The Fortunato family home—A home on Prospect Avenue in Hermosa that is about to break ground; retrofit to be 2200 sq. ft. and will produce more energy than it uses. He said tpartners are all donating their services to help get this home off the ground, modeling where to place the home, how to place the windows, etc., to ensure that it is protected from the sun in the summer and collects the sun in the winter. The data will be available online in order for others to leverage the information for their own use. This project gave the City the idea to do it as a municipality, then a school system, and then as a community. The real goal is to have a community that is carbon neutral.

Mayor DiVirgilio explained the purpose of becoming carbon neutral. He said it provides a new suite of options for leveraging the financial incentives and brings social benefits. This effort should keep Hermosa Beach environmental leaders - providing improved quality of life; fostering economic redevelopment and developing a more sustainable budget. He said the LA County retrofit program will be leveraged to fit Hermosa Beach, with some samples being: neighborhood competitions; measure things in different ways; appliances bought or energy projected to be saved; engage the community in a way that doesn't force them to do anything but they will get value in the short term because of the stimulus money that will help them buy appliances.

Chair Mitchell thanked Mayor DiVirgilio for his presentation, noting that the scale is an excellent example that could be adopted in other cities.

Mayor DiVirgilio said that if Hermosa's work could benefit what other cities are doing he welcomes their input and participation. He said the seed is a carbon neutral ad hoc committee that meets on Friday nights; they interact with the SBESC and they appreciate the expertise and advice from Marilyn Lyon and others at the Service Center.

Special Metro Update from Deputy Chief Executive Officer Paul Taylor

Chair Mitchell introduced Mr. Paul Taylor, Deputy CEO Metro, who spoke on behalf of Art Leahy who was unable to attend the meeting. Mr. Taylor thanked Al Patashnick and Michael Bolhke for their support over the years.

Mr. Taylor explained that the management at MTA wants to work with the COGs and bring them into what the MTA is doing because they are needed. The biggest project at the MTA is the implementation of Measure R in an equitable and accelerated way. He reviewed a number of actions taken at the Board meeting today and recently, including: the hiring of an underwriting team for bond issues that could involve as much as \$1 billion in cash flow; hoping to do it under the federal program that has a 35% interest rate subsidy, providing lower cost capital than normal; approving the highway improvement projects in the South Bay; extensions of the Green Line to LAX. He said he believes the COGs have had a major role in implementing Measure R and they count on the COG for advice and action.

Mr. Taylor said he met with Jacki Bacharach today at the Artesia Transit Center and saw a number of things that can be improved. He said he has pledged to form a task force to start taking action and it looks to be a tremendous resource that is underutilized and unattended to.

Jacki Bacharach said she held the first meeting with the consultant on SBCCOG Measure R Highway Implementation and they have pledged that by January they will have an implementation plan for early start projects. They are looking for projects that could be freeway related in that they relieve traffic on the freeways. Cities are encouraged to work with the consultants right away to identify projects in their cities for this funding and so that the list and analysis is completed in 6 months..

Mr. Taylor encouraged the cities to be forthcoming with good ideas and make lists of the things they would like to apply the revenues to. He said he believes the Board will look favorably on these uses. Using jointly the real estate the MTA owns with others for private use and he looks forward to working with the COG on what that could be.

Jacki Bacharach explained that improvements to the Artesia Transit Center are part of the Congestion Reduction Project which is the toll project on the I-110 and the concern is that the project still includes funding for a plan for getting off the freeway at Adams but not the funding for doing it.

MONTHLY METRO REPORT

Board member report by Mike Bohlke for Pam O'Connor, who was not available due to a city council meeting that ran late.

This Month Supervisor Knabe became the Chair of the MTA board of Directors and has assigned Director O'Connor to the following MTA Board Committees: Planning and Programming (Chair); Finance & Budget, Operations, and Ad Hoc Sustainability Committee (Chair).

MTA Board approved the [South Bay COG Highway Implementation Plan project](#) and the programming of \$2 million in Measure R funds for the project.

Board approval of the EIR for the HOT Lanes for I-10 and the I-110, the Board also approved the O'Connor/Knabe Board Policy amendment to ensure that in the subsequent drafting of the HOT Lanes Revenue Guidelines and Expenditure Plan for the I-110 Corridor the Artesia Transit Center will be a priority for those revenues. This will not exclude or preclude other priorities within the I-110 Corridor, but establishes early on the need to focus on the Artesia Transit Center as the primary terminus for the I-110 Hot Lanes corridor. This is just another means to bring attention to the on-going needs of the Artesia Transit Center and to ensure that it is included as a recipient of any revenue stream produced by the Hot Lanes in that Corridor.

The Board also approved the use of \$7.9M in CMAQ funds for the purchase of 8 buses for Torrance Transit's establishment of the Torrance-Long Beach Rapid Corridor, a major step for Torrance and the last element in the MTA/BRU Consent Decree's "New Service" provision that was still outstanding.

The Planning & Programming Committee took up the matter of the Artesia Transit Center's need for restrooms and a status report from the staff on the O'Connor Motion from February. Staff was instructed to return with the update on the following information:

1. A Draft proposal on revising the existing MTA restroom policy to reflect the need for public restrooms at Metro facilities that are (1) geographically remote; (2) due to such geographical remoteness can provide no access to nearby public or private restroom facilities within a reasonable walking distance, and (3) contain Sheriff Substations on the premises.
2. The Timing and cost to install restroom facilities at the Artesia Transit Center
 - a. Temporary facilities to coincide with the opening of the Sheriff substation and permanent replacement; and
 - b. On a permanent basis cost estimates for both a "brick & mortar" and the alternative of Automated self-cleaning Public Toilets
3. The Board further instructed staff to Meet and Confer with the South Bay Sector Council for their review and input on the above issues, and
 - a. Signage solutions at the Transit Center; and
 - b. Bus Bay Identification issues – which bay should people go to catch their bus.
4. Update the Committee on the status of Caltrans conveying the Artesia Transit Center property to Metro including an overview of the potential opportunities this extremely large parcel offers for joint development.

Governance Council report by Ralph Franklin & Jim Goodhart

Jim Goodhart reported on recent activities of the Governance Council.

Ralph Franklin said the SB Governance Council does their job well. He said they address their concerns with Art Leahy and get results, most recently the concerns about the Artesia Transit Station and the Crenshaw LAX Corridor that will tie into the Green Line. They also recognized the support of Pam O'Connor, Don Knabe and their staffs in helping them get their point across and work gets done.

Jacki Bacharach said she still feels that the South Bay Sector Council is different than the others in that they have a majority of non-elected officials and they have ride the bus system. Franklin mentioned that kiosks are available at the various city halls that make it easier to determine what lines to take to their destination.

Board Member Rhilinger reported that the City of Torrance has received funding for 8 new buses and a rapid bus beginning in February 2011.

In response to Jacki Bacharach's inquiry regarding the TAP card and when the MTA might be able to make a presentation to the COG, Mike Bohlke said they will be holding a lot of meetings in order to address their concerns and the deputies will meet with the respective parties.

Paul Taylor added that he said he has had several meetings with the municipal operators and he believes the real issue is the multiplicity of the expectations of what the TAP system will do. He said 95% of the needs will be covered but there will be some needs that won't be covered. He believes enough progress will be made by October or November in what the problems are that need to be resolved.

SOUTH BAY ENVIRONMENTAL SERVICES CENTER UPDATES

Update on current programs and activities

Marilyn Lyon distributed a list of upcoming events and invited everyone to participate. She reviewed one of the West Basin programs "Cash for Kitchens" where commercial kitchens receive an audit, efficiency measures and training. They also look for emergency efficiency measures that could be implemented. They have saved close to 5 million gallons of water and referred some restaurants for further audit to help with more savings.

Marilyn Lyon said the stimulus projects are moving along; consultant has worked with Torrance and Carson to identify a couple of lighting projects and SBCCOG is on track to meeting the goals with Edison. A list of the schools in all cities has been provided and they are working on energy savings. She . She asked cities not to be discouraged about the PACE (property assessments for clean energy)energy program being placed on hold. A letter to President Obama asking him to continue the PACE program for homeowners nationwide was distributed. She said the county program happens with or without PACE. The program will launch October 1st for contractors, giving them the tools to work with so they can speak to their customers. There will be a "splashy" launch state-wide in January.

Jacki Bacharach asked the COG to approve sending a letter to the Congress regarding PACE. She said because the PAE financing isn't available, other methods of financing are being worked out and could even benefit more people.

SBCCOG UPDATE AND COMMITTEE REPORTS

Jacki Bacharach announced the next meeting of the Green Task Force next Thursday, July 29 at 1:30 p.m.

SB 375 status

Jacki Bacharach reported that the South Bay strategy will be brought to the Board in September for discussion of some of the ramifications of having a blueprint that is less transit oriented.

LUV update

Jacki Bacharach reported:

- the COG now has 6 vehicles, each has a GPS on board and we can see where they're going. She said staff has met with Edison regarding the data being collected to help them determine where they could install EV charging stations;
- A meeting was also held with Toyota about their EV infrastructure and new product line.
- the vehicles have been purchased through a grant with buy-back provisions whereby the vehicles will be for sale at the end of the project.

AB 1998 – Manhattan Beach

Mayor Mitch Ward asked for support of AB 1998 --- the plastic bag ban that has passed the Assembly and is moving toward the Senate. He explained that Manhattan Beach was the first city in the South Bay to ban the bags but that the ban was challenged in the courts and the Supreme Court has agreed to hear the appeal. He distributed a staff report used to draft Manhattan Beach's resolution and asked individual councils to take a position of support in addition to the COG taking a position as a whole.

In response to Chair Mitchell's inquiry whether there is time to refer to the COG's Legislative Committee, Jacki Bacharach said the deadline is August 2nd for the hearing and therefore there is no time to wait.

Chair Mitchell said she has reviewed the proposed legislation and noted that the League of Cities Board policy committee is concerned with pre-emption of local control; however, they voted to support the legislation with the proviso that there be an exemption for the point of sale; and that stores would still be required to take back plastic bags and recycle them. It was noted that AB 1998 currently repeals those provisions.

Richard Montgomery (Manhattan Beach) explained that the minimum square footage is 10,000 sq. ft. so fast-food restaurants will be exempt. This is the first time the California Growers Association and the Union also support it, but first opposed it.

Dan Medina (Gardena) said NBC news did an article on bags for larger items, noting that the company that makes them is marketing to all of the grocers to get them to use recyclable bags.

John Parsons said the issue of old reusable bags containing E. coli needs to be addressed, since people don't clean them regularly.

Board Member Franklin asked for the definition of single-use plastic bags and expressed concern regarding where do you draw the line between recyclable and "tote".

Jacki Bacharach reported that the hearing will be held August 2nd and it must pass or fail by August 31st. She said this means the COG has the constraint but cities have more time.

MOTION by Board Member Goodhart, seconded by Board Member Rhilinger, to support the bill with amendments consistent with the League recommendation. Motion passed with the following vote:

Favor: El Segundo, Gardena, Lawndale, Manhattan Beach, Palos Verdes Estates, Rolling Hills Estates, Torrance;
Opposed: Inglewood, Lomita, Redondo Beach; Rancho Palos Verdes

Abstain: County (Steve Napolitano)

Jacki Bacharach announced the need for members on the Legislative Committee, chaired by Ellen Perkins, and invited any city council member to participate.

AGENCY REPORTS

SCAG & Committees (Matt Horton)

Mat Horton reported that SCAG will go dark in August. He said there will be ARB workshops, with the Ventura workshop available for webcast.

South Bay Cities City Managers' Association (Doug Prichard)

Greg Grammer, Rolling Hills Estates, reported that the South Bay City Managers have been discussing the Bell situation and will be sending letters to the editors letting the public know that this is not what city managers are about.

Workforce Investment Board – John Parsons

John Parsons reported on several items, including but not limited to: approaching the end of the initiative introduced by Supervisor Knabe that put 10,000 people to work, noting over 10,000 jobs were created in over 3,000 companies. A lot of these people have been hired by the companies they worked for, but without additional funding some will be unemployed. County Board of Supervisors approved funding for summer youth employment.

He reported on the Rapid Response numbers: 14 companies put out more notices for layoffs and or closings; staff provides information on unemployment. He said it would be helpful if cities that know a company is closing would inform the WIB so these services can be provided before the employees are gone.

He announced the annual Alumni Breakfast on October 28th with a "Moving Mountains" theme, noting that the winner is Supervisor Knabe.

September 9th – Mike Jenkins presentation; going through Bill of Rights – now, 2nd amendment.

Public Utilities Commission staff – workshop before the Board meeting in October.

**VEHICLE LOAN AGREEMENT BETWEEN
THE CITY OF SANTA MONICA
AND
THE SOUTHBAY CITIES COUNCIL OF GOVERNMENTS**

This Vehicle Loan Agreement (“Agreement”) is made and entered into on the 9th day of August 2010 (“Execution Date”) by and between the CITY OF SANTA MONICA hereinafter referred to as the “City” and the SOUTH BAY CITIES COUNCIL OF GOVERNMENTS, hereinafter referred to as the “SBCCOG”, and is set forth as follows:

BACKGROUND

A. The SBCCOG is conducting a South Coast Air Quality Management District (AQMD) funded demonstration project, Local Use Vehicle (LUV) Pilot Project (“Pilot Project”), on the effectiveness and acceptance of Neighborhood Electric Vehicles (“NEVs”) in reducing emissions and the impacts of NEVs on local roads. NEVs are electric vehicles limited to 25 mph and legal to operate on roads with speed limits of 35 mph or less.

B. The City shares the goals of reduced emissions and encourages the use of NEVs through free parking at meters and electric charger placement throughout the City. The City also owns 32 NEVs, used in many applications throughout the City. NEVs are less expensive than traditional municipal vehicles and are well suited for municipal service.

C. SBCCOG LUV Pilot Project will collect data to help identify the concerns and solutions for the safe, effective use of NEVs in our communities. The City seeks to obtain said data from the Pilot Project

D. The City agrees to loan, and SBCCOG agrees to accept, one NEV for a period of one year for use in the Pilot Project under the terms and conditions set forth herein.

AGREEMENT

A. TERM.

The term of this agreement will commence on the Execution Date, and shall terminate at midnight on November 30, 2011.

B. LOAN VEHICLE.

The City will loan to SBCCOG one Neighborhood Electric Vehicle, referred to as the 2009 Miles ZX40 ST, bearing vehicle identification number LECPT22B39T000245 for use by

the SBCCOG's LUV Pilot Project to increase the number of vehicles in the demonstration. In exchange, the SBCCOG will share data, best practices and lessons learned with the City. The vehicle will be used by the public, businesses and/or others participating in the SBCCOG LUV Pilot Project to collect data and feedback on the use and experience, provided such participant executes a license agreement in a form attached hereto as Exhibit 1. A GPS tracking device will be installed at no cost to City and will be removed when the vehicle is returned to the City. SBCCOG agrees to be responsible for all the costs of repairs and maintenance of the vehicle during the term of the Agreement.

C. INDEMNITY.

The SBCCOG shall indemnify, defend, and hold harmless City and its officers, directors, employees, and agents ("Indemnitees") from and against any and all liability, expense (including, but not limited to, defense costs and attorneys' fees), claims, causes of action, and lawsuits for damages of any nature whatsoever including, but not limited to, bodily injury, death, personal injury or property damage (including property of SBCCOG) arising from or connected with any alleged act or omission, negligence, fault or violation of law or ordinance by SBCCOG, its officers, directors, employees, agents, subcontractors, suppliers or participants ("Indemnitors") in connection with the use of the Vehicle, the Pilot Project or SBCCOG's use or maintenance of the vehicle. Indemnitors also agree to reimburse City for the loss of said vehicle up to the Fair Market Value (at the time the loan is originally made) of the vehicle. This indemnity shall survive the termination of this Agreement.

SUMMARY AS OF:

5/27/2010--Introduced.

Electric Vehicle Deployment Act of 2010 - Establishes within the Department of Energy (DOE) a national electric drive vehicle deployment program.

Directs the Secretary of Energy (Secretary) to: (1) develop a national plan for electric drive vehicle deployment; and (2) provide, upon local request, technical assistance to communities with the deployment of plug-in electric drive vehicles.

Establishes a targeted plug-in electric drive vehicle deployment communities program.

Amends the Internal Revenue Code with respect to the income tax credit for each new qualified plug-in electric drive motor vehicle placed in service during the taxable year. Allows a refundable personal credit for a qualified deployment community taxpayer. Extends the credit for modification of new qualified hybrid motor vehicles. Revises requirements for the alternative fuel vehicle refueling property credit. Allows a tax credit for qualified plug-in electric drive motor vehicle refueling property bonds.

Amends the Energy Policy Act of 2005 to authorize the Secretary to make loan guarantees for certain charging infrastructure and networks of charging infrastructure for plug-in drive electric vehicles.

Amends the Public Utility Regulatory Policies Act of 1978 to require each electric utility to develop a plan to support the use of plug-in electric drive vehicles in its service area.

Declares electricity consumed by federal agencies to fuel plug-in electric drive vehicles an alternative fuel subject to federal fleet management reporting requirements.

Directs the Administrator of General Services to acquire plug-in electric drive vehicles and the requisite charging infrastructure for deployment in the federal fleet.

Directs the Secretary to establish: (1) an Advanced Batteries for Tomorrow Prize to advance the research, development, demonstration, and commercial application of a 500-mile vehicle battery; and (2) a program to fund research and development in advanced batteries, electric drive vehicle components, electric drive infrastructure, and other related technologies.

Establishes in the Treasury the 500-mile Battery Fund.

Directs the Secretary to: (1) implement a research, development, and demonstration program pertaining to the secondary uses of vehicle batteries; (2) provide grants for development of a secondary market for batteries; and (3) study the recycling of materials from plug-in electric drive vehicles and their batteries.

Directs the Secretary of the Interior to study and report to Congress on the supply of raw materials needed to manufacture such vehicles, batteries, and other related components, as well as the infrastructure needed to support them.

Establishes a Plug-in Electric Drive Vehicle Technical Advisory Committee.

Directs the President to establish a Plug-in Electric Drive Vehicle Interagency Task Force.

Amends the Energy Independence and Security Act of 2007 to direct the Secretary to guarantee loans to eligible entities for the aggregate purchase of at least 200 qualified automotive batteries in a calendar year with a total minimum power rating of 1 megawatt and advanced battery technology.

Directs the Secretary to develop and publish: (1) model building codes for the inclusion of charging infrastructure in new construction and major renovations of private residences, buildings, or other structures; and (2) related model construction permitting or inspection processes, as well as model zoning, parking rules, or other local ordinances.

Directs the Secretary to award grants to educational institutions and qualified training programs for vocational workforce development, through centers of excellence, of skills needed to maintain plug-in electric drive vehicles and associated infrastructure.

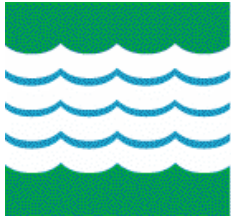

Dear Member of Congress:

On behalf of the South Bay Cities Council of Governments (SBCCOG), I am writing to ask for your urgent support for legislation that guarantees local government the right to establish clean energy programs, known as Property Assessed Clean Energy (PACE). PACE is a local government solution that helps home and building owners finance energy efficiency and renewable energy improvements and is supported by a century of legal and historical precedent for special assessment districts, including more than 37,000 districts that have been used to finance sewers, sidewalks, and other projects that serve a public purpose.

We strongly believe that recent actions by federal regulators infringe upon state and local power to utilize assessment districts and that PACE is good for our nation's housing industry and mortgage investors. In just the past two years, twenty-two states have passed laws enabling local governments to develop PACE programs (CA, CO, FL, GA, IL, LA, ME, MD, MN, MO, NV, NH, NM, NY, NC, OH, OK, OR, TX, VT,

State and local governments have embraced PACE because of its tremendous potential to cut energy bills, increase homeowner cash flow for mortgage payments, reduce mortgage default risk, create tens of thousands of local jobs and dramatically reduce greenhouse gas emissions by spurring investment in clean energy improvements.

PACE has received strong bipartisan support nationwide because creating jobs, saving energy and reducing utility bills for families and businesses is important to all Americans. Our nation's PACE programs were set to launch a 24 month pilot period this summer, funded by \$150 million in grants from the Department of Energy, incorporating safe and sound consumer and lender protections that were developed by a White House led inter-agency working group consisting of HUD, NEC, OMB, CEQ and DOE.

Unfortunately, despite PACE's great promise, the Federal Housing Finance Agency (FHFA) and the Office of the Comptroller of the Currency (OCC, collectively the "Regulators") issued recent statements blocking our nation's PACE pilot programs. The Regulators action is a direct challenge to state and local powers to levy tax assessments for a public purpose and wrongly asserts that the consumer and lender protections are not sufficient. The DOE funded PACE programs have been specifically designed to help the mortgage market yet the Regulators statements simply rehashed old concerns that have already been addressed. Because of FHFA's oversight of Fannie Mae and Freddie Mac, and OCC's influence over our nation's banks, the statements forced existing PACE programs to halt and froze the ability to launch PACE programs already under development nationwide.

We are working to implement a major energy efficiency program in conjunction with Los Angeles County and PACE financing will be extremely helpful to incentivize homeowners to participate. Therefore, we urge Congress, which chartered Fannie Mae and Freddie Mac, and which established FHFA & OCC, to quickly intervene and pass legislation that guarantees the right of state and local government to form special assessment districts to promote clean energy programs and restore the promise of PACE.
